

WMP Production and Quota Update September 2023

WMP Pre-Pooling Production Update

Daily average production in September was 6.404 million litres, an increase of +3,916 litres (or +0.06 per cent) over August's pre-production of 6.40 million litres. The average butterfat density in September was 4.28 kilograms per hectoliter, a 2.42 per cent increase over August 2023.

When comparing the September production data on a year-over-year basis, it shows a 0.61 per cent decrease in litres in the 12-month period ending September 2023 over the 12-month period ending September 2022; and a 1.66 per cent increase in butterfat production for the same period. Quota Update

The WMP's rolling 12-month CDC quota decreased by 0.09 per cent in August from July. The WMP's daily producer quota issuance in August 2023 was 273,806 kg/day, 99.74 per cent relative to the past 12-month average CDC quota allocation.

Pools' Quota Utilization

Cumulative Quota Positions (CQP) at the end of August 2023 for the WMP, P5 and P10 were -0.65, +1.90 and +0.91 per cent respectively. This means that the respective pools on a cumulative basis are all over or under-producing by their respective percentages as indicated.

The 12-month quota fill rates for the WMP, and the P5 in August 2023 are 97.44% and 100.74% respectively. The WMP under-filled its monthly CDC quota allotment by -639,129 kilograms of butterfat in August 2023 or -7.16 per cent compared to -8.65 per cent for the same period last year.
