# WMP Pre-Pooling Production Update

Daily average production in February was 6.793 million litres, an increase of +98,641 litres (or +1.47 per cent) over January's post- pooling production of 6.695 million litres. The average butterfat density in February was 4.5280 kilograms per hectoliter, a 0.06 per cent increase over January 2025.

When comparing the February production data on a year-over-year basis, it shows a 1.51 per cent increase in litres in the 12-month period ending February 2025 over the 12-month period ending February 2025; and a 3.51 per cent increase in butterfat production for the same period. ### Quota Update

The WMP's rolling 12-month CDC quota increased by 0.54 per cent in January over December 2024. The WMP's 12-month daily producer quota issuance in January 2025 was 291,384 kg/day, 100.45 per cent relative to the past 12-month average CDC quota allocation.

# Pools' Quota Utilization

Cumulative Quota Positions (CQP) at the end of January 2025 for the WMP, P5 and P10 were -3.13 +2.58 and +0.56 per cent respectively. This means that the respective pools, on a cumulative basis, are over or under-producing by their respective percentages as indicated.

The 12-month quota fill rates for the WMP, and the P5 in January 2025 are 98.75% and 101.75% respectively. The WMP over-filled its monthly CDC quota allotment by 813,523 kilograms of butterfat in January 2025 or +9.48 per cent compared to +11.40 per cent for the same period last year.
