


WMP Production and Quota Update August 2025

WMP Pre-Pooling Production Update

Daily average production in August was 6.913 million litres, an increase of +1,841 litres (or +1.47 per cent) over July's post- pooling production of 6.911 million litres. The average butterfat density in August was 4.3153 kilograms per hectoliter, a 0.20 per cent increase over July 2025.

When comparing the August production data on a year-over-year basis, it shows a 4.05 per cent increase in litres in the 12-month period ending August 2025 over the 12-month period ending August 2024; and a 6.0 per cent increase in butterfat production for the same period. Quota Update

The WMP's rolling 12-month CDC quota increased by 0.98 per cent in July over June 2025. The WMP's 12-month producer quota issuance in July 2025 was 291,078 kg/day, 98 per cent relative to the past 12-month average CDC quota allocation.

Pools' Quota Utilization

Cumulative Quota Positions (CQP) at the end of July 2025 for the WMP, P5 and P10 were -1.42 +2.27 and +1.04 per cent respectively. This means that the respective pools, on a cumulative basis, are over or under-producing by their respective percentages as indicated.

The 12-month quota fill rates for the WMP, and the P5 in July 2025 are 100.54% and 101.18% respectively. The WMP under-filled its monthly CDC quota allotment by 240,406 kilograms of butterfat in July 2025 or -2.54 per cent compared to +1.60 per cent for the same period last year.
